## **TERMS & CONDITIONS: -**

10. No financial assistance shall be granted by the Department to the school.

11. School premises shall not be used for commercial purpose and anti National activities.

 Approval of Managing Committee shall be obtained from the appropriate authority in case of any change in the committee.

 The Managing Committee shall follow the instructions issued by Government/Director from time to time and supply the information to the Govt. / Department as required.

14. In addition to above the Managing Committee shall abide by the provisions of Haryana School Education Rules, 2003 and amendments if any thereafter. The Managing Committee shall be liable for disciplinary action in case of violation of any provisions of the rules.

15. School will provide ramp within six months otherwise recognition will stands withdrawn.

If any information, at any stage found Contrary to the Fact's the recognition would be revoked forthwith.
 That the number of students in classroom shall not be more than the students calculated on the basis of 10 square feet per student for secondary and Senior Secondary Schools and 9 Square feet per student for elementary state.
